We are currently working on a draft bill that would hold the employers of unlicensed therapists equally as responsible as the individuals themselves. It would also address the issues around individuals obtaining licenses illegally from the state of Connecticut. We are trying to have the bill contain the eastern styles of "Shiatsu", "acupressure", and 'Thai Massage', to protect the public from unlicensed individuals from using that language as a loop hole.

I would like to thank the entire Board of Directors from the past 4 years. I have learned so much from them and they have ALWAYS had my back, even when others may not have. I have made quite a few stumbles along the way. They have worked with me, been patient with me, and have never taken any of my actions personally. They have picked me up whenever I have stumbled. The "Marilyns" have been incredibly patient with me as I have missed just about every deadline possible. They now give me an earlier one just so I can get the information to them on time!

I would also like to thank you....the members of our chapter. Even though I have not met everyone, it is because of each and every one of you that our chapter is as successful as it is. I just got back from National office this week and I was told repeatedly how wonderful Connecticut is as a chapter. It is always brought back to the member of the organization. ## It's time for Chapter Elections!

## The board positions that are available in April 2012, along with the job descriptions, are listed below:

#### These are two year positions.

**President:** The Chapter President sets the direction and pace of the Chapter's activities based on the vision that has been determined by the Chapter membership, Chapter Board of Directors, and other Chapter Officers. The Chapter President serves as a leader, planner, mentor, mediator, and facilitator. In addition to being a Professional member in good standing and signing the Volunteer Code of Conduct, Connecticut requires that she/he must meet one or more of the following requirements:

- Completed one term year as a Chapter Board member within the last three years.
- Completed one term year as a Chapter committee chair within the last two years.
- Completed one term year as a National Standing Committee Chair or National Board member within the last two years.

**Time Commitment:** The time commitment is approximately 5 - 15 hours per week, depending on Chapter activities. The time commitment may be higher before and/or during certain National or chapter events or activities.

**Authority:** The authority of the Chapter President is conferred by the Chapter membership through election, as the highest-ranking elected officer in the Chapter, and as specified in the National AMTA Bylaws, Policy, and Chapter Standing Rules.

Accountability: The Chapter President is accountable to the Membership by virtue of election and to the Chapter Board, the Chapter membership and the AMTA National Board through reporting activities. The Chapter President agrees to uphold and abide by National AMTA Bylaws, Policy, Job Description, Chapter Volunteer Code of Conduct, and Chapter Standing Rules (if applicable), and Financial Policies & Procedures.

<u>2<sup>nd</sup> Vice President:</u> The Chapter Vice President will assist the Chapter President in achieving Chapter goals and effecting policies and/or decisions made by the Chapter Board of Directors. In Connecticut, the 2<sup>nd</sup> VP is responsible for communication within the chapter. This includes working with the Chapter newsletter, website, and Facebook page volunteers.

**Eligibility:** Candidate must be a Professional member in good standing and sign the Volunteer Code of Conduct.

**Time Commitment:** The time commitment averages approximately 5 - 8 hours per week, depending on Chapter activities. The time commitment may be higher before and/or during certain Chapter events or actions.

**Secretary:** The Chapter Secretary is the official keeper of the Chapter records and is responsible for maintaining and updating Chapter records during her/ his term of office.

**Eligibility:** Candidate must be a Professional member in good standing and sign the Volunteer Code of Conduct.

**Time Commitment:** The time commitment is approximately 2 - 4 hours per week, depending on Chapter activities.

#### These are one year positions.

Membership Director: Obtain and maintain the current membership list from National AMTA. Keep the AMTA CT Board of Directors and Ambassador Chair apprised of the membership list in a timely fashion including numbers of new members and dropped members. This position is also responsible for building our membership. They can do this by developing a membership committee that does presentations to various schools in the state, contacts new members to encourage their participation as well as contacting dropped members to encourage further association with the Chapter. This is a position that can be fun and creative. It can give someone the great opportunity of meeting new people and developing new and innovative programs with the assistance of the Board of Directors and other committee members.

**Sports Director:** In general, the Sports Director is responsible for the coordination of all aspects of the CT Sports Massage Team. This includes, confirming dates, times and coordinators for ongoing team events.

This individual seeks out additional events that would give Team Members experience with national, international, professional and amateur athletes. They must work with the Board of Directors to constantly fine tune the operating standards for the Team, including qualifications of members, maintaining sports team boxes, statistics and publicity.

The Sports Team Director can be a co-directorship, and of course they must keep up the tradition of having a Team Banquet at the end of the season!

Education Director: In general this position is responsible for organizing all aspects of continuing education for the chapter membership. This includes researching, contacting, negotiating with and working out logistics of workshops to meet the CE Hour requirements of the AMTA. They work closely with the Treasurer to secure contracts with presenters. They are also responsible for the documentation of all workshops including CE certificates; sign in sheets, evaluation forms, and equipment. The Education Director is really responsible for a tremendous part of the outreach program to our members. This position researches current trends, listens to members on what they want to learn and then puts great programs together. They work with the 2<sup>nd</sup> Vice President and the Communications Committee to ensure appropriate publicity for the workshops. The CT Chapter has a great reputation for excellent CEU programs.

Please send your completed application, optional resume, and a signed code of conduct to <u>COC@amtactchapter.org</u> no later than April 16th, 2012. They will not be accepted after this date and nominations will be taken from the floor.

# 2012 Delegate Elections Are Here....

Delegate elections are here and there are plenty of changes!!

**Eligibility:** Delegates now have a limit of three consecutive terms. Per AMTA Bylaws, term limits are cumulative. All delegates must be a Professional member in good standing, must be a member of the chapter whose members they represent, must sign the AMTA Delegate Code of Conduct, and shall not be an AMTA National Board member.

Eligible delegates elected during our 2012 annual meeting will serve a two-year term.

All delegates begin serving at the same time as newly elected chapter officers. Our chapter has 5 delegates, last year we elected three delegate positions to a twoyear term and elect two delegate positions to a one-year term. This year, we will elect two delegates to a two year term. If you run for delegate, and you are not in the top two, you automatically become an alternate for a two year term.

**Call for nominations from the floor:** We will ask each candidate if they are willing to accept the nomination from the floor. <u>This will ONLY occur if we do not have at least two delegates running.</u> Once nominations are closed, and delegates have signed the delegate Code of Conduct, we will call each candidate up alphabetically to deliver a 2-minute speech if they desire.

We will distribute ballots with the names of all of those nominated. Tellers committee (use the same Teller's committee from officer elections) is to count votes and provide the results to the Chapter President.

The delegate with the highest number of votes fills delegate number 1 slot; the delegate with the 2nd highest number of votes fills the 2nd slot, and all other candidates fill the roles of alternates in order based on most votes received.

Everyone who is eligible will become either a delegate or an alternate. The Connecticut Chapter sends our 5 delegates and top 5 alternates to the National Convention of the years that they have been elected. Alternates will hold a two-year term. If an alternate is called upon to replace a delegate they will complete the term of the delegate that they are replacing. For instance, if a delegate that has been elected in 2011 resigns, the next 2011 alternate in line will replace that delegate and complete the balance of their 2-year term. If a delegate that has been elected in 2012 resigns, the alternate from 2012 will replace that delegate and complete the balance of their term. If an alternate is slated to replace a delegate, the next alternate, starting with #11 will step into the #5 alternate position.



## community service massage team



## Government Relations Update Already a busy season.

Flushing Update: As you know we have a major issue concerning an unusual number of individuals from Flushing NY applying for and receiving or are pending receipt of CT Massage Therapist license. This is of major concern to our organization and profession because there have been questions raised as to the qualifications of many of these individuals and the validity of both their education and test taking abilities. Throughout the US there have been instances of fraudulent documentation of education as well as discrepancies in test taking. We are concerned that there is much more going on here than noticeable at first glance and have taken our concerns to our Government, the Health Department and local Representatives as well as NCBTMB. The following is a summary of our efforts. Please note that the time may come for our members, YOU, to act and get involved. Stay tuned to see what form we need that participation to take.

A Team of representatives from the CT Chapter of the AMTA have met or will be meeting with the following individuals. Our representatives at these various meetings have included: Scott Raymond, President, Jodi Wolf, 1<sup>st</sup> VP, Lee Stang, IPP, Lisa Torre, LOT Chair, Shirley Cooper, member, Judy Yost, Lobbyist. Also at some of these meetings were Representative Linda Orange and Representative Jack Hennessy, both strong supporters of the Massage profession and the AMTA.

Meeting with Commissioner of Public Health, Dr. Jewel Mullen: discussed at length the issue of licensing and Flushing NY. Found many issues that are of concern to us, primarily that the State DPH does not have a list of approved schools that they work from in terms of checking on the accreditation of schools people graduate from per our statute. They also do not work with NCBTMB to ensure that the individual taking the test is the individual applying for the license. The DPH told us they would look into this issue.

The DPH also recommended to us that we also meet with the Dept. of Education and the Attorney Generals' office on concerns about the accreditation issue of some schools that people are graduates of and the possible issue of trafficking.



**Meeting with Attorney General, George Jepson:** This was the first meeting of our Chapter Representatives with the Attorney General. Of primary discussion was the issue of how the DPH issues licenses and the Flushing NY concern. In summary the Attorney Generals' office is going to look into the process DPH uses to ensure that people that receive CT MT licenses are indeed qualified to do so.

Attorney General Jepson was quite concerned about the possible human trafficking issue and strongly recommended that we schedule a meeting with the US Chief State Attorney to discuss this issue.

Pending meeting with United States Chief States Attorney: We are in the process of establishing a meeting with the US Attorney. Our Lobbyist Judy Yost has been instrumental in securing meeting times for us and is currently working on this.

Meeting with Representative Audin Grogins from Bridgeport: Now while all this has been happening our Lobbyist has been diligently monitoring the happenings in the legislature. She found a Representative that was proposing another bill relating to Massage Therapy. Initially it appeared that bill was another attempt to regulate massage by requiring some sort of state license to operate a massage establishment. Judy arranged a very quick meeting with us and Representative Grogins, the bill sponsor. Also in attendance were Representatives Linda Orange and Jack Hennessy.

What this meeting made clear to us is that no matter how much we believe that we have educated Legislatures on our issues and even on the current statutes they are often unaware unless one of their constituents has raised a concern with them on a related issue. Representative Grogins currently has constituents that are concerned with the number of 'Massage Parlors' that have opened in the Bridgeport area. She was, however, unaware of the details of our current statutes. She was concerned that the current law does not have enough 'meet' to it to be truly enforceable at the local level. She also was very willing to listen and be educated by us while at the same time was adamant that she wanted to put a bill forward.

The meeting was collaboration. Initially it would place an additional financial burden on the Massage Profession by having a fee associated with another license of sort for the establishment. We informed her that we could not support legislation that increased fees for legitimate Massage Therapists in any way. With our collaboration she changed the focus of the bill. This focus will be three fold as we currently understand it: 1) Add Shiatsu, Acupressure, at Thai bodywork to the marketing/advertising piece of our current law. This way those unlicensed individuals cannot get around the law by advertising their massage as one of these modalities; 2) directing the DPH to compare the picture of the person that takes the national exam with the person that applies for the license. They can request exam photos from NCBTMB; 3) hold the business owner responsible for the hiring of unlicensed staff to do massage. Currently it is only the therapist that falls under the statute and thus is the one that can be fined or charged with a class C misdemeanor. The owner goes unscathed. This will change that.

We currently await the language of this Bill before we can fully support it. We have some reservations surrounding it so need the language to ensure it will be helpful to our profession and members. As this article is being written Scott Raymond and Lee Stang are reviewing the bill proposal and heading back to the capitol to meet with Representative Grogins regarding it. **NCBTMB:** Finally we will be scheduling a meeting with NCBTMB representatives regarding the issue in Flushing. We must look at how so many people from questionable schools have been able to sit for the National Exam and to see what if anything can be done to strengthen procedures around this. In our dealings to date with NCB they have been quite concerned about this issue and receptive to meeting with us. It is only a matter of time before this happens.



Legislative Awareness Day: This year the date is April 11. With all that is going on it is IMPERATIVE that we have a good turnout at the Capitol. We are working to have Project Rescue with us to display the harmful ramifications of human trafficking and will also display the issues we currently face as well as information regarding any legislation we are supporting. It is important for us to arrive in force and be prepared to communicate our concerns to the legislature. Many people have signed up to help with this at the chapter meeting. You can also contact Lee Stang at impastpresident@amtactchapter.org to sign up. There will be two shifts: 9-1 and 1-5 (both with arrival 15-30 minutes prior). Again the date is April 11 in the Hall of Flags at the Capitol building.

So it has been a busy time for Government Relations. It is important for our members to keep a lookout for eblasts calling for action. So be prepared. Find out who the Representatives and Senators are in your area, we will need your assistance in contacting them. It is obvious that if they do not hear from their constituents they will not be as informed about our issues as we need them to be. So get ready for action!

## AMTA Releases Annual Research on Massage Therapy Profession

## AMTA Launches Fascial Therapy CE Program

AMTA launched a fascial therapy continuing education program designed to keep massage therapists current in the profession and to advance their knowledge and skills. AMTA was recognized in May by Association Media & Publishing (AM&P) for the excellence of its social media strategy and the Career Guidance area of its website. The association's social media innovation, especially its approach as a nonprofit association to use of Facebook, was awarded a Gold EXCEL Award, while its website Career Guidance section received a Silver Award. As of January 1, 2012 AMTA's Facebook page has more than 17,000 followers.

## How to Report Unethical Behavior and Illegal Practices

The question often comes up about policing our own profession if a therapist or establishment is practicing inappropriately. Members want to know what recourse we have with the state and what they will do if contacted.

Begin the process by calling the CT Department of Public Health (DPH): (860) 509-7552. They will send you a form to fill out, which needs to be notarized by a notary public before you send it back.

You will need the following information: Practitioner's name; the name of the business where they are practicing; and the business address and phone number. Also, your name, address, and phone number where the DPH can contact you.

Write your specific concerns as 1. 2. 3.etc. and then specify your complaint with only as much detail as necessary to give them a solid background so they can make a sound decision.

After attaching any documentation you have to support the complaint, you want to check to make sure that everything is legible, clearly written and notarized. It is a good idea to make a copy of everything for your files before sending it to:

CT Dept. of Public Health ATTN: Investigation Unit 410 Capitol Avenue Hartford, CT 06106

The department looks over the complaint and decides whether or not to go forward with disciplinary action. If so, it goes to the legal department for further action. The next step is a hearing for a decision.

In the past there have been cases where therapists have had their licenses revoked, had to practice under supervision, and/or received recommendations for counseling. It is in the best interest of our profession to follow through with the process when we know of practices that could be damaging to our reputation.
